Fellow of the University of Melbourne	Council	Exceptional contributions or service to the University and/or to a community engaged with the University.	<ul style="list-style-type: none"> • Approval requires endorsement from GNC
Wilson Medal	Council	Outstanding contributions or service to the University from the community, or from staff in the event that a staff member makes a significant philanthropic contribution.	<ul style="list-style-type: none"> • Approval requires endorsement from GNC • Council may approve the awarding of the Wilson Medal to a staff member who, to Council's satisfaction, makes a significant philanthropic contribution even if the value is less than \$1 million.
	Council OR Vice-President (Advancement, Communications and Marketing)	Outstanding philanthropic contributions to the University from the community, or from staff provided the cumulative philanthropic contribution is \$1 million or above	
Gold Medal	Council	Exceptional service to the University by members of staff and those serving in an honorary capacity, on or after retirement.	<ul style="list-style-type: none"> • Approval requires endorsement from GNC
Silver Medal	Council	Exceptional service in a particular capacity or field of activity by members of staff and those serving in an honorary capacity, on or after retirement.	<ul style="list-style-type: none"> • Approval requires endorsement from GNC
Bronze Medal	NA (Note: The Executive Director, Human Resources and Occupational Health and Safety is responsible to ensure that eligible recipients receive the award.)	25 years of service by members of academic or professional staff.

Sir William Upjohn Medal	Council	Individuals for distinguished services to medicine in Australia.	<ul style="list-style-type: none"> Recipient must be resident in Australia for at least three out of the five years preceding the award. Approval requires endorsement from GNC on the on the recommendation of a committee consisting of the dean of the faculty, Dentistry and Health Sciences ('the faculty') (or nominee) and such other persons as may be appointed by the Council on the recommendation of the faculty. Established under a trust. Open for awarding every five years
Brownless Medal	Council	Those who have made an outstanding contribution to the Melbourne Medical School and who through their diligence and leadership have ensured its remarkable success.	<ul style="list-style-type: none"> Approval requires endorsement from GNC on the recommendation of Melbourne Medical School's Awards Committee in the Faculty of Medicine, Dentistry and Health Sciences
Hyslop Medal	Council	Individuals whose outstanding contributions have been integral to the success of Social Work at Melbourne	<ul style="list-style-type: none"> Approval requires endorsement from GNC on the recommendation of the Hyslop Medal Committee in the Faculty of Medicine, Dentistry and Health Sciences
TG Tucker Medal	Council	An academic staff member of the Faculty of Arts for their outstanding performance and excellence in scholarship. The TG Tucker Medal will be awarded to those who through their performance in research, teaching and learning, engagement and service and leadership have made a substantial contribution to the Faculty.	<ul style="list-style-type: none"> Approval requires endorsement from on the recommendation of
The Woodward Medal in Science and Technology	Deputy Vice-Chancellor (Research) (<i>a delegate of Council</i>)	A member of staff for research published in the preceding five years which is considered to have made the most significant contribution by a member of staff to knowledge in a field of science and technology.	<ul style="list-style-type: none"> Approval is on the recommendation of a separate committee. Each committee comprises the Deputy Vice-Chancellor (Research) or nominee who is Chair and a minimum of four members of academic staff appointed by the Deputy Vice-Chancellor (Research). Established under a trust.
The Woodward Medal in the Humanities and Social Sciences		A member of staff for research considered to have made the most significant contribution to knowledge in a field of humanities and social sciences.
